Commissioner's List of Electronic Textbooks Cost Summary

There are 55 products on the Commissioner's List of Electronic Textbooks submitted by 9 different publishers. Several publishers submitted products in more than one category and for multiple grade levels. Publisher contracts are being finalized and specific pricing for each product will be made available once contracts are executed. Below is a summary of the costs of materials on the list. Bids are for a six-year period.

Six publishers submitted 23 products at approximately 10% below max cost.

Example: Maximum cost = \$72.74 Bid = \$65.46

Three publishers submitted 5 products at approximately 25% below max cost

Example: Maximum cost = \$85.04 Bid = \$63.75

One publisher submitted 3 products at approximately 45% below max cost

Example: Maximum cost = \$72.50 Bid = \$40.00
