## CONCURRENT RESOLUTION

- 1 WHEREAS, The future of Bentsen-Rio Grande Valley State Park
- 2 is threatened by the proposed construction of a border wall through
- 3 this treasured site; and
- WHEREAS, In 1944, the Bentsen family signed over nearly 600
- 5 forested acres along the Rio Grande to the Texas Parks Board for the
- 6 consideration of \$1, with the stipulation that the land be used
- 7 "solely for Public Park Purposes"; it opened to the public as a
- 8 state park in 1962, and while serving as a wildlife corridor that
- 9 allows native species to survive, it has drawn people from across
- 10 the country to observe its diverse fauna; and
- 11 WHEREAS, Today, as part of the World Birding Center, the park
- 12 ranks among the nation's premier bird-watching destinations; it
- 13 attracts some 30,000 visitors annually, with numbers growing by
- 14 about five percent every year, and it is an important driver of the
- 15 Rio Grande Valley's ecotourism economy; and
- 16 WHEREAS, U.S. Customs and Border Protection has notified
- 17 landowners of plans to build a 33-mile barrier in Hidalgo and Starr
- 18 Counties; the section in Hidalgo County will consist of vertical
- 19 concrete river levees topped by 18-foot-tall fencing, as well as a
- 20 150-foot-wide "enforcement zone" on the river side with a road,
- 21 around-the-clock lighting, cameras, and sensors; and
- WHEREAS, Scientists have warned that the construction of such
- 23 a barrier through this sensitive natural area would devastate
- 24 wildlife habitat; a border wall would also inhibit access and deter

- 1 visitors, and it would likely result in the discontinuation of
- 2 overnight camping and nighttime wildlife viewing; moreover, the
- 3 proposed barrier would divide the park, isolating the headquarters
- 4 and visitors center from the area enjoyed by the public and creating
- 5 serious operational, management, and safety issues; further
- 6 complicating the issue, if TPWD is no longer able to safely operate
- 7 the property as a state park, under the terms of the original grant,
- 8 the land could revert to the heirs of the grantor; closure of the
- 9 park could also negatively impact the viability of the neighboring
- 10 National Butterfly Center; and
- 11 WHEREAS, Bentsen-Rio Grande Valley State Park is a jewel of
- 12 the Texas Parks and Wildlife Department, beloved by state residents
- 13 and visitors from far and wide, and it should be protected for the
- 14 benefit of generations to come; now, therefore, be it
- RESOLVED, That the 86th Legislature of the State of Texas
- 16 hereby respectfully urge the United States Congress to oppose
- 17 construction of a border wall through Bentsen-Rio Grande Valley
- 18 State Park; and, be it further
- 19 RESOLVED, That the Texas secretary of state forward official
- 20 copies of this resolution to the president of the United States, to
- 21 the president of the Senate and the speaker of the House of
- 22 Representatives of the United States Congress, and to all the
- 23 members of the Texas delegation to Congress with the request that
- 24 this resolution be entered in the Congressional Record as a
- 25 memorial to the Congress of the United States of America.
