
Dewhurst Prioritizes Public School Finance, Higher Education

The Texas Senate had an extraordinarily successful Special Session this spring. We passed a school finance bill that not only improves our public schools, but also reduces local school property taxes by one-third the year after next. Local school property taxes are too high in Texas, and high property taxes hurt homeowners and businesses. I didn't want to just solve the school finance lawsuit and lower local school property taxes—I wanted to improve our public schools. There is nothing more important to you and to me than ensuring our children have the opportunity to succeed in life. We must provide our children with the necessary tools to get good jobs and achieve their version of the American Dream. I appreciate the work of Senator Judith Zaffirini and the other members of the Senate Committee on Education for putting Texas children first.

Another priority of mine last session was to pass HB 153, legislation sponsored by Senator Zaffirini, that authorizes universities in Texas to issue \$1.9 billion in tuition revenue bonds—state-backed bonds used to construct needed new classrooms and buildings. This year, Texas A&M International received \$37.5 million in bonds. I am proud that the Senate passed this unprecedented piece of legislation that is the largest investment in higher education in the history of our state.

Our universities play key roles in ensuring the future success of our state. Zaffirini's Eight Amendments Improve School Finance Bill

EXPANDING ACCESS REMAINS TOP PRIORITY

During the three special sessions called by the governor to address public school finance, Senator Judith Zaffirini continued to prioritize creating opportunities for all Texas children to attain an excellent education. Specifically, her priorities included developing an equitable school finance system; increasing funding for meaningful teacher pay raises; restoring fully the promised health-care stipend for teachers and support personnel; meeting transportation, bilingual and special education needs; and reducing property taxes.

The new law passed by the Texas legislature in May contained many of these provisions, largely because of amendments authored by Senator Zaffirini. These included removing onerous language that would have impacted students with limited English proficiency and restoring the health care stipend for school support personnel.

House Bill 1 will reduce property taxes by an historic \$15.7 billion and the net tax burden by \$6.9 billion by 2009. It also raises teachers' salaries by \$1,500 and implements a new broad-based business tax.

"Although I voted against all the tax bills, I voted for HB 1 because it will improve levels of equity between rich and poor schools and add \$1.4 billion to public schools," Senator Zaffirini said. "Nevertheless, I opposed sections of the new law, including its pro-

viding a less than meaningful pay raise of \$3,000 for teachers; failing to restore completely the teacher health care stipend; privatizing low-performing schools; and providing an ill-fated incentive program for teachers before they are paid adequately."

Senator Zaffirini added eight amendments to HB 1:

- Restoring the health care stipend for support personnel;
- Ensuring that accountability measures for students with limited English proficiency focus on dual language proficiency instead of English only;
- Providing free pre-kindergarten services to children of active duty members of the armed forces, members of the National Guard or Reserves or of armed services members who are killed or injured while serving;
- Allowing children to protect themselves from severe allergy attacks by self-administering anaphylaxis medication;
- Authorizing any student who lives in the same household as a student with special needs also to transfer to the same campus where the sibling will receive special education services;
- Extending the national free or reduced-price breakfast and lunch program to a greater number of eligible public school students;
- Improving the operation of the Texas School for the Deaf; and
- Maintaining the reporting of parental involvement programs at low-performing campuses.

Capital Funding Subcommittee

Recognized repeatedly as a champion of education in general and of higher education in particular, Senator Judith Zaffirini chairs the newly created Subcommittee on Capital Funding for Higher Education (SCCFHE).

During the 2006 Third Called Special Session she passed a \$1.9 billion tuition revenue bond (TRB) bill and developed an aggressive higher education legislative agenda that she will build upon during the 2007 legislative session.

As chair of the SCCFHE, Senator Zaffirini will lead the subcommittee as it reviews the process for funding construction, renovation and technology infrastructure on higher education campuses throughout the state.

"I am delighted that Lt. Gov. David Dewhurst named me to chair a subcommittee that will develop important policies related to higher education funding," said Senator Zaffirini, the fourth-highest ranking senator and the highest-ranking senator for Bexar County and the border region. "This subcommittee will play an important role in expanding higher education opportunities for all willing Texans."

Subcommittee members are Zaffirini, chair; Senators Robert Duncan, R-Lubbock; Kyle Janek, R-Houston; Steve Ogden, R-College Station; and Royce West, D-Dallas.

"Higher education is the key," Lt. Gov. Dewhurst said. "This subcommittee will play an important role in ensuring that our college campuses continue to grow and that they are able to meet the future demands of a growing student population."

\$1.9 Billion TRB Bill

Senator Zaffirini and her subcommittee played a critical role in securing \$1.9 billion for TRBs that will enable universities to build much needed classroom and research facilities. House Bill 153 by Rep. Geanie Morrison, R-Victoria, and Senator Zaffirini, provided 63 TRBs for 48 colleges and universities throughout Texas, including institutions in the systems of Texas A&M University, The University of Texas, University of Houston, Texas State University, University of North Texas and Texas Tech University. Independent universities receiving bond authority include Texas Woman's University, Midwestern State University, Stephen F. Austin State University, Texas Southern University and Texas State Technical College at Waco.

"This significant investment is not only equitable for our citizens, it also will improve their accountability," Senator Zaffirini said. "Higher education is my passion, it truly is to work with Lt. Gov. Dewhurst, Rep. Morrison to build education facilities in Texas and across the state."

HB 153 included \$37.5 million for A&M International University, \$25 million for the Student Center at the University of Texas at Dallas, \$7.6 million for the Loop Water Loop and \$4.9 million for the Fine and Performing Arts Center at the University of Texas at Dallas.

The University of Texas at San Antonio received bond authority for to construct a satellite campus. What's more, Senator Zaffirini helped secure \$40 million for Texas State University in San Antonio, \$74,250,000 for a new building at the University of Texas at San Antonio and \$60 million for a new Research Facility at the University of Texas Health Science Center at San Antonio.

Senator Zaffirini also included funding for the citrus center building at Texas A&M University in Kingsville. V

University of Texas at Brownsville received \$33,800,000 for a Science and Technology Learning Center, and Texas A&M University at Corpus Christi received \$40 million for a nursing, health and kinesiology facility.

Her legislative priorities for 2007 include providing tax-free textbooks for college students, expanding the state work-study financial aid program to allow students to serve as peer tutors and mentors, improving the transferability of community college students, expanding dual-credit programs that allow high school students to earn college credit and increasing math and science participation, especially among female and minority students.

Higher Ed Priorities

Several priority higher education bills passed by Senator Zaffirini during the 2005 session are reforming higher education in Texas significantly.

She continues to focus not only on increasing opportunities for student success, but also on expanding access to college. HB 1172 by Senator Zaffirini and Rep. Fred Brown, R-College Station, for example, implemented uniform grade-point average and timely graduation requirements for state financial aid programs. SB 34 by Senator Zaffirini and Rep. Morrison provides a university student with a \$1,000 rebate for completing studies timely.

In addition to encouraging more timely graduation, SB 34 allows students to serve as non-voting members of boards of regents of university systems.

"The student regent will not only provide valuable insight and information, but also will serve as a liaison between students and regents," said Senator Zaffirini.

Initiatives improve health, public safety, economic opportunities

Senator Judith Zaffirini has passed 515 bills since 1987, including 58 bills during the 2005 legislative session.

With Rep. Lon Burnam, D-Ft. Worth, she passed Senate Bill 271—the “Texas Missing Angels” bill, which allows parents of a stillborn child to secure a certificate signifying that the birth resulted in stillbirth. Previously, there was no official recognition that a stillborn child was born, and parents received only a certificate of fetal death.

Senator Zaffirini also worked closely with transplant physicians and organ recipients while authorizing legislation to create an organ donor registry. House Bill 120 by Rep. Glenda Dawson, R-Pearland, and Senator Zaffirini will help connect willing organ donors with the more than 5,600 Texans waiting for lifesaving transplants. Every 13 minutes, a new name is added

to the national transplant waiting list. An average of 17 persons die every day while waiting for an organ.

To improve organ donation, the Donor Education Awareness and Registry (DEAR) will be online by Sept. 1. In addition to listing persons who are willing to donate their organs, DEAR will create educational and awareness activities.

A champion of improving the health and economic infrastructure of *colonias* along the Texas-Mexico border, Senator Zaffirini and Rep. Ryan Guillen, D-Rio Grande City, passed SB 827,

which creates a system for tracking the progress of state-funded projects that benefit colonias. Since September, 2005, representatives from eight state agencies and Senator Zaffirini’s staff have been working diligently to develop a classification system to rate the health risks of each colonia in the state and to assess the types of state projects funded for each colonia.

“By identifying the colonias with the least resources, we can prioritize funding to construct roads, build housing and improve infrastructure in the communities that have the most critical need,” Senator Zaffirini said.

HB 1058 by Rep. Joe Pickett, D-El Paso, and Senator Zaffirini allows school districts to issue a high school diploma to honorably discharged veterans who served in World War II, Korea or Vietnam and were scheduled to be graduated from high school between 1940 and 1975.

Sister Judith: Senator Zaffirini Named Honorary Nun

After being named “Mister” South Texas in 1999, Senator Judith Zaffirini was named “Sister Judith” by the Sisters of Mercy and Mercy Ministries. They made the senator an honorary nun for her outstanding public service and commitment to improving health and wellness for Texas families.

“I am proud to be ‘Sister Judith’ and share this recognition with the many groups and persons, including the Sisters of Mercy and Mercy Ministries, who unite to promote, champion and improve health and human services, particularly for the needy,” Senator Zaffirini said.

Mercy Ministries provides primary healthcare, healthcare education and social services and acts as a safe haven for victims of domestic violence. The organization aims to address the needs of all persons, especially those who are economically poor and marginal.

“Because I grew up with nuns and always have worked

with them, I learned not only to prioritize faith, but also to collaborate in achieving our mutual goals,” Senator Zaffirini said. “From them I learned the truth of the (translated) words of Luciano de Crescenzo: ‘We are all angels with only one wing, and only by embracing each other can we fly.’”

As vice chair of the Senate Finance Committee and chair of the Appropriations Conference Committee Article II Workgroup for Health and Human Services during the 2005 legislative

session, Senator Zaffirini restored mental health, chiropractic, hospice, podiatry, hearing aid and vision benefits to both the Children Health Insurance Program and Medicaid.

A long-time advocate for persons with disabilities, Senator Zaffirini fought to reduce waiting lists for persons waiting to receive community-based services, some of whom have been on the lists for more than 10 years. In the state budget for fiscal year 2006-07, Senator Zaffirini secured \$162.9 million to move 11,789 persons from waiting lists to programs.

A former chair and current member of the Senate Health and Human Services Committee, Senator Zaffirini’s legislative successes include passing bills to immunize all Texas children; facilitate independent living for persons with disabilities; and reform Medicaid, indigent health care, welfare, nursing homes, adoption and child support.

Interim Presents Opportunity to Develop Local Bills

The interim at hand is an opportune time to develop legislation for the forthcoming session, especially for bills that impact SD 21 communities directly.

Examples of local bills include legislation to create or affect a water district, hospital district, local court or juvenile board.

Because securing and demonstrating local support is imperative, the senator requires resolutions in support of local bills to be adopted by impacted county judges and commissioners

courts, mayors and city councils, and local organizations and residents.

Equally important, the hometown senator and representative should agree to sponsor identical bills. Without the leadership of both local legislators, local bills will fail. Accordingly, supporters of local bills must work with both or risk failure.

Legislators must comply with Texas Constitutional requirements in filing local bills timely. To file a bill on Jan. 14, for instance, legislators must

attach a publisher’s affidavit that the bill’s caption was published in a local newspaper by Dec. 14. Without at least a 30-day advance public notice, a local bill cannot be filed. The procedure for publication is provided by statute (Chapter 313, Government Code) and can be accessed via the Internet at <http://www.capitol.state.tx.us/statutes/gv.toc.htm>.

Senator Zaffirini Honored for Leadership, Communications

Senator Judith Zaffirini will begin her 20th year in the Texas Senate in 2007. This is a memorable achievement for the first Hispanic woman ever to be elected to the body and to serve as President Pro Tempore and Governor for a Day.

Named one of *Texas Monthly's* "10 Best Legislators" for 1997, 2001 and 2005, Senator Zaffirini is distinguished by her flawless voting record and legendary work ethic. She recently was named an honorary nun by the Sisters of Mercy, and her legislative successes in diverse

areas including higher education and health and human services have been recognized by many organizations.

The senator has won more than 555 awards for her professional and public service work, including more than 90 for communication projects. Awards received during this interim include the Texas Advocacy Award from the American Cancer Society, the Texas Hospital Advocacy Tribute from the Texas Hospital Association and special recognition from the Mid Río Grande Border Area Health Education Center for her countless legislative contributions

benefiting health and education programs in South Texas.

Senator Zaffirini also received numerous awards in a wide array of media categories from the Press Women of Texas and the Communicator Awards.

Since 1987 she has maintained a 100 percent perfect attendance record in the Texas Senate, except for breaking quorum deliberately in 2005 to prevent an untimely redistricting effort that hurt her district. In June, 2006, the U.S. Supreme Court ruled that this same redistricting effort violated the Voting Rights Act and dis-

enfranchised voters living in SD 21. From 1987 through the 2006 special sessions she maintained her 100 percent voting record, casting more than 34,000 consecutive votes. She has sponsored and passed 515 bills and 51 substantive resolutions and co-sponsored and passed another 253 bills.

Senator Zaffirini and her family carry on a proud tradition as Texas Exes who bleed burnt orange. At UT she honed her resolute work ethic to earn B.S., M.A. and PhD degrees, each with a 3.9 GPA. Hard work, de-

termination and devotion to studies are words of advice Senator Zaffirini has given to thousands of students at college and high school commencement ceremonies and events.

She has been married to Carlos Zaffirini, a graduate of UT Law School, for more than 40 years. Together they share an office in Laredo where he practices law, and she owns an award-winning communications firm, Zaffirini Communications. Their son, Carlos Jr., is a graduate of the UT McCombs School of Business and a 2006 graduate of the UT School of Law.
