

Texas Department of Licensing and Regulation 4th Quarter Update October 4, 2012

- Texas Department of Licensing and Regulation (TDLR) Executive Director Bill Kuntz presented the agency's legislative appropriations request on 2 October to a joint budget hearing that included staff from the Office of the Governor, Office of the Lieutenant Governor, Office of the Speaker, Senate Finance Committee, House Committee on Appropriations, and Legislative Budget Board.
- The Texas Commission on Licensing and Regulation met on 26 September. Senate Business and Commerce Committee Director Steven Polunsky attended the meeting and presented to the Commission during public comment concerns Chairman John Carona has regarding implementation of the Licensed Breeders program. The Commission took the following actions during the meeting:
 - Approved new criminal conviction guidelines for the Licensed Breeders program.
 - Approved revised penalty matrices for the Towing, Vehicle Storage Facility, and Booting program.
 - Approved the following advisory board member appointments:
 - -Stacey Mighty Malcolm of Katy (public member) to the Electrical Safety and Licensing Advisory Committee.
 - -Stephanie Palmer of Wills Point (licensed breeder) to the Licensed Breeders Advisory Committee.
 - -Philip G. Pearce of College Station (consumer); Andrew I. Combs, P.E., of Carrollton (building professional); Jim Durham of Waco (consumer); and B. Todd Gritch of Dallas (building professional) to the Architectural Barriers Advisory Committee.
 - -John Pyburn of Manvel (representative of the Gulf Coast) and David C. Vasquez of Sugar Land (public member) to the Water Well Drillers Advisory Council.

- The Barber and Cosmetology schools performance and refund study report required by Senate Bill 1170 by Carona was issued on 31 August. The report, entitled *Barber and Cosmetology Schools: Performance and Refund Study*, is available at http://www.license.state.tx.us/cosmet/RefundStudy.pdf.
- As of 1 October, TDLR has received 136 Licensed Breeders program applications and has issued 75 licenses. Eleven licensees hold a Class A U.S. Department of Agriculture breeder license. The Licensed Breeders program was enacted through House Bill 1451 by Thompson/Whitmire during the 82nd Texas Legislature's Regular Session in 2011. - Effective 15 October, individuals who apply for a Licensed Court Interpreter (LCI) license are required to complete the LCI Orientation Course, information about which is at http://www.license.state.tx.us/court/lciOrientationCourse.htm, prior to taking the written and practical exams.
- Effective 1 November, HB 2643 by Hamilton/Watson changes the Air Conditioning and Refrigeration Contractors law to require applicants to have at least 48 months of practical experience working under the supervision of a licensed AC contractor, within the preceding 72 months. The bill also added provisions that allow TDLR to substitute some experience for education in various certification programs and degrees, and to accept experience earned in apprenticeship programs, military service, and government employment.
