2019 THE COURTS THAT REVIEWED THOSE MAPS FOUND THAT THOSE MAPS INTENTIONALLY DISCRIMINATED

AGAINST PEOPLE OF COLOR. NOW TRUMP'S DEPARTMENT OF JUSTICE HAS PRESSURED GOVERNOR ABBOTT TO

REDISTRICT PREDOMINANTLY BLACK AND HISPANIC DISTRICTS "BECAUSE THEY WERE DRAWN ON THE BASIS OF

RACE"! THEIR GOAL IS TO DILUTE MINORITY POWER AND DENY FAIR REPRESENTATION. DIVIDING THOSE

DOES NOT DESTROY ASPECTS OF LEGISLATURE'S WORK (DATA, COMMUNICATIONS, CONSULATIONS,

PROPOSALS). CLAIMS OF LEGISLATIVE PRIVILEGE HAVE NO PLACE IN REDISTRICTING.
