The Texas Secretary of State's website confirms that I am a Qualified Candidate for U.S. House of Representatives CD-18 for the Special Election. These redistricting hearings are still being held without the installation of an interim representative to advocate and speak on the behalf of the constituents of CD-18. I am again, submitting a public statement to this honorable body (as I have before), requesting that a joint resolution (and/or executive order be issued by the State Senate, State House of Representatives, and State Governor, as set forth herein:

#### JOINT RESOLUTION/EXECUTIVE ORDER

To Recognize and Install Feldon Bonner II as the Interim Advocate and Designated Community Representative for Texas Congressional

District 18 Pending the Special Election

WHEREAS,

The United States Constitution (Article I, Section 2) provides that when vacancies occur in the House of Representatives, the

executive authority of the state shall issue writs of election to fill such vacancies; and

A vacancy currently exists in Texas Congressional District 18, leaving its constituents without direct representation in the U.S. House

of Representatives; and

Feldon Bonner II has fulfilled the legal requirement for candidacy by filing and paying the mandatory \$3,125.00 fee to be placed on the

ballot for the Special Election to fill the vacancy for Congressional District 18, as confirmed by the Office of the Texas Secretary of

State; and

The principles of representative democracy require that the citizens of all congressional districts — including those historically

underrepresented — not be deprived of representation, voice, or advocacy during the redistricting process or while urgent federal

matters are underway; and

It is in the public interest and constitutional spirit of equity and representation to ensure that no constituency is left voiceless in

matters of federal engagement, policy discussions, or congressional redistricting hearings; and  
Other states have previously installed interim representatives, advocates, or liaisons in extraordinary or emergency circumstances to

uphold the interests of the electorate during representation gaps;

NOW, THEREFORE, BE IT RESOLVED/ORDERED:

#### SECTION 1. INSTALLATION OF INTERIM REPRESENTATIVE

Feldon Bonner II is hereby installed and publicly recognized as the Interim Liaison, Community Advocate, and De Facto Congressional

District 18 Representative for the State of Texas, empowered to represent the public and political interests of Congressional District 18

before all state and federal authorities, committees, and agencies.

#### SECTION 2. SCOPE OF AUTHORITY

This designation authorizes Feldon Bonner II to:

- Engage with U.S. Congressional committees and submit public policy recommendations on behalf of District 18;
- Represent District 18 constituents during state-level and federal redistricting proceedings;
- Advocate for federal legislative, appropriations, and civil rights matters affecting the district;
- Testify in official hearings or forums as the community voice of District 18; and
- Coordinate with federal, state, and local agencies in a recognized liaison capacity.

#### SECTION 3. DURATION

This resolution/order shall remain in effect until the certified winner of the Special Election for Texas Congressional District 18 is sworn

into office by the U.S. House of Representatives, unless rescinded or amended by further legislative or executive action.

#### SECTION 4. LEGAL DISCLAIMER

This designation does not confer formal voting rights or congressional membership, but it provides functional legitimacy and standing

for public engagement and intergovernmental representation on behalf of the constituents of District 18.

Election for Congressional District 18 is officially sworn into office by the United States House of Representatives.

##### 6.2. Travel and Per Diem

In addition to the stipend, the State of Texas shall reimburse all official travel, lodging, and meal expenses incurred by Feldon Bonner II

in the fulfillment of his public duties, consistent with the state per diem rates and reimbursement procedures.

##### 6.3. Office and Administrative Support

Feldon Bonner II shall be granted access to appropriate administrative support, including:

- A designated office space,
- Telecommunications and internet access,
- Printing and mailing support,
- And a temporary assistant or staff aide, funded through existing state resources or legislative district support funds.

#### 6.4. Funding Source

The financial support authorized under this section shall be drawn from the Office of the Governor's Emergency Funds, Legislative

Reserve Accounts, or other legally permissible appropriations designated for civic engagement, public liaison activities, or emergency community representation.
