Message:

WHEREFORE,

- Texas last redistricting was in October 2021, approved by a Republican Party majority vote;
- On June 11, 2025, the Texas Tribune reported President Donald Trump's political advisors were urging Governor Abbott to call a Special Session to redraw congressional map with an aim to flip seats to Republican Party;
- On June 23, 2025, Republican Governor Abbott advised of his plan to call a Special Session, the agenda of which did not contain any redistricting item;
- On July 7, 2025 the Department of Justice advised, almost four years after the last redistricting plan, that four Texas districts allegedly violated racial discrimination laws and for Texas to correct the problem – the timing of this mid-term election edict is extremely suspect as to who and the motive behind encouraging the complaint;
- On July 9, 2025, Governor Abbott issued a Proclamation, adding a redistricting item to the Special Session agenda in response to the DOJ letter;
- On July 11, 2025, in regard to Exhibit A Attachment to the case filed in U.S. District Court, El Paso Division, No. 3:21-cv-00259-DCG-JES-JVV, the Texas Attorney General office responded to the DOJ letter that the legislature did not pass race-based electoral districts;
- On July 15, 2025, Republican President Donald Trump publicly advised Texas Republican Governor Abbott to secure 5 additional Republican Party seats in the House of Representatives;
- The Texas House and Senate redistricting committees are holding short 5 hour redistricting public hearings without having issued any redistricting maps and giving little notice of the events;
- The Texas House and Senate redistricting committees are rushing the redistricting process without giving reasonable time for the Public to make informed comments;

NOW, THEREFORE, given the inconsistent and conflicting rationale for advancing the redistricting effort based on racial discrimination excuse; the rushed, disorganized and fundamentally incomplete format of giving the illusion of Public hearings; the apparent singular purpose of redistricting is at the extreme of pure gerrymandering as advanced by President Donald Trump, Governor Abbott and the Republican Party to increase the number of Texas Republican Party House of Representative Congressional Seats;

The redistricting process has gone beyond the bounds of being just a political question, but the racial justification excuse, uncanny timing of events and partisan participants, estranged

incomplete public disclosure of objectives, has resulted in the redistricting process to be unnatural, absurd and/or so tortured an exercise, to inherently contravene the Voter Rights Act of 1965 and the Constitution because the redistricting performance results in voter frustration and disengagement from the political process – in effect inherently preventing or interfering with the exercise of one’s legal voting rights, undermines democratic principles and political fairness – seek redress of grievances.
