To Whom It May Concern,

I am writing to express my deep opposition to the proposed congressional redistricting plan currently under consideration in Texas. At the heart of this redistricting proposal lies a disturbing pattern: the dilution of minority voting power. Redistricting is meant to ensure fair representation. Instead, this proposal weaponizes it. It is part of a broader trend in Texas politics that seeks to suppress voter turnout and restrict access to the ballot box. From stringent voter ID laws to reduced polling locations in minority communities, the state has already made it harder for many Texans to vote. The answer seems clear: to preempt demographic shifts and lock in political power before the electorate can respond. This is a power grab, plain and simple. It circumvents the normal democratic process and sets a dangerous precedent for future manipulation.

Texas has long prided itself on its independence. From its history as a republic to its fierce defense of state sovereignty, Texans have always believed in charting their course. But this redistricting plan suggests a troubling shift: a willingness to bend to the will of national political figures, particularly President Trump.

The fingerprints of Trumpism are all over this proposal—from its disregard for minority rights to its embrace of authoritarian tactics. By aligning itself with this agenda, Texas risks losing its identity. It becomes just another pawn in a national political game, rather than a state that leads with integrity and vision.
