Dear Editor Reeve,

This article, "Texas secretary of state 2020 election audit finds miscues by Harris County, but no widespread fraud," doesn't reveal the magnitude of the failure of former County Clerk, Chris Hollins foray into drive-through voting, and 24-hour voting in 2020. Despite Judge Hidalgo calling the forensic audit by the Texas Secretary of State's office "an irresponsible political trick. It is a sham. It is a cavalier and dangerous assault on voters and democracy," last September, the audit accurately reflects the complete failure to document and track ballots as well as a lack of chain of custody. For example, they failed to maintain voter record documentation on mobile ballot boxes (MBBs) that under the law was supposed to be kept for 22 months.

According to the SOS audit report, the County Clerks Election division "created" 17 MBBs to cover 124,630 voter records that used drive-through voting without any documentation and then threw out the equipment used to read these MBBs (aka digital ballots for the layman.)

Thus, no one can verify these voter records whatsoever because 17 MBBs simply cannot be read. Therefore, Texans will never know what exactly happened to a medium-sized city's worth of drive-through voting records!

Harris County was randomly selected to be audited in 2022. It should reveal why the previous Election Administrator (EA) lost ten thousand votes in the primary only to find them later, or why thousands of county voters were turned away from the polls in November as the current EA either couldn't or wouldn't provide enough ballot paper for them to vote on. Those are real threats to democracy!
